In this organization women's average hourly wages are 21% less than men's. For every dollar men earn in average hourly wages, women earn 79 cents in average hourly wages. *

Median hourly pay gap²



In this organization women's median hourly wages are 29% less than men's. For every dollar men earn in median hourly wages, women earn 71 cents in median hourly wages. *

In this organization women's average overtime pay is 54% less than men's. For every dollar men earn in average overtime pay, women earn 46 cents in average overtime pay. *

In this organization women's median overtime pay is 63% less than men's. For every dollar men earn in median overtime pay, women earn 37 cents in median overtime pay. *

In this organization women's median bonus pay is 69% less than men's. For every dollar men earn in median bonus pay, women earn 31 cents in median bonus pay. *



As a unionized electrical construction contractor, the collective agreement sets out the wage rates for approx. 80% of our workforce. Women currently make up approx. 4% of the electrical trade.
